I. Call to Order

Chairman Gilman called the meeting to order at 6:00 PM.

II. Nonpublic Session I

- a. Chairman Gilman made a motion to enter nonpublic session at **6:00 PM** per RSA 91-A:3, II(a) *The dismissal, promotion, or compensation of any public employee or the disciplining of such employee, or the investigation of any charges against him or her, unless the employee affected (1) has a right to a public meeting, and (2) requests that the meeting be open, in which case the request shall be granted.* Selectman Griffin seconded the motion. Roll call vote: Chairman Gilman - yes, Selectman Griffin – yes, Selectman Bilodeau – yes. All in favor, the motion carries. Town Administrator Brenda Pearl was present during this nonpublic session.
- b. Chairman Gilman made a motion to come out of nonpublic session at **6:48 PM**. Selectman Bilodeau seconded the motion. All in favor, the motion carries.
- c. Chairman Gilman made a motion to seal the minutes because it is determined that divulgence of this information likely would affect adversely the reputation of any person other than a member of this board. V. Nonpublic Session III

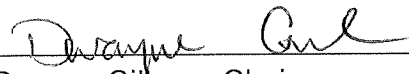
