1st Reading

JJJ Access to Public School Programs by Non-Enrolled Resident Students

(a) The dismissal, promotion, or compensation of any public employee or the disciplining of such employee, or the investigation of any charges against him or her. (b) The hiring of any person as a public employee. (c) Matters which, if discussed in public, would likely affect adversely the reputation of any person, other than a member of the board. (d) Consideration of the acquisition, sale, or lease of real or personal property. (e) Consideration or negotiation of pending claims (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions. (j) Consideration of confidential, commercial, or financial information. (k) Consideration by a school board of entering into a student or pupil tuition contract. (l) Consideration of legal advice provided by legal counsel. (m) Consideration of whether to disclose minutes of a nonpublic session.
